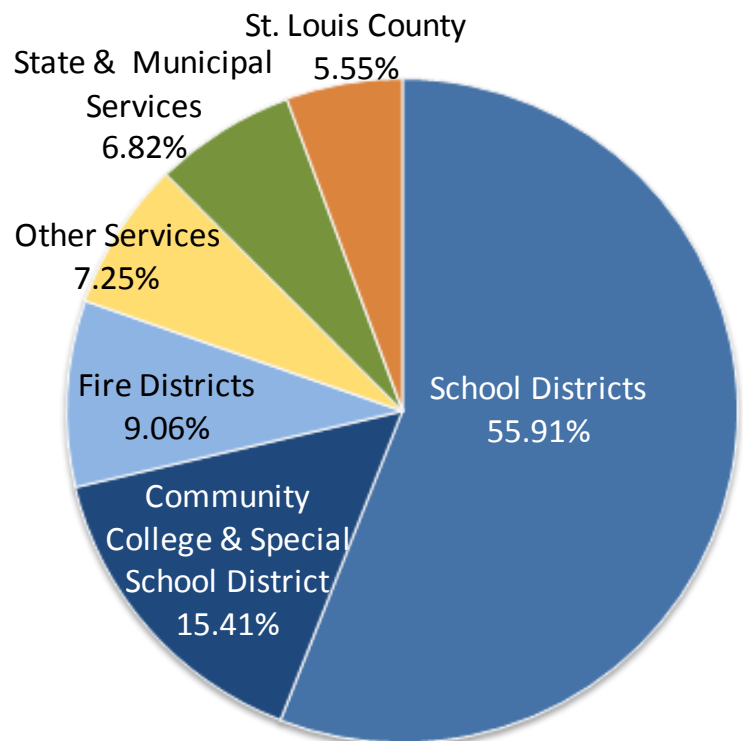

Collector's Office

Bills, collects and distributes \$1.8 billion annually for the more than 250 different taxing districts located in Saint Louis County: Personal and real property taxes, railroad and utility taxes, and merchant's and manufacturer's taxes.

Recorder of Deeds

Accepts real estate deeds and plats for official recording and issues marriage licenses.

Board of Equalization

Conducts property value appeal hearings during July and August, and monthly exemption hearings.

Trustee Property

Maintains inventory of properties that have not been sold at the Collector of Revenue's delinquent tax sale auction.

- Solicits, qualifies and administers the sale and transfer of those properties.

Licensing

Issues and administers licenses, collects the convention and tourism tax, and the convention and sports tax.
