PROPERTY TAX INSTALLMENT PAYMENT PROGRAM

Enclosed please find an application for participation in the St. Louis County Personal Property and/or Real Estate Tax Installment Prepayment Program.

To be eligible for the prepayment installment program, a taxpayer must complete an application identifying each personal or real property tax account you are requesting installment payments for. The total tax billed amount, based on last year's taxes, must be a minimum of \$100 for personal property and a minimum of \$100 for real estate to be eligible. Only this year's tax, **no delinquent years will be eligible.**

Once you complete the enclosed application and return it to our office, we will then send you a statement for quarterly pre payments which will be due on or before March 31, June 30, and August 31. A finalized tax bill will be mailed in November with the balance due and payable on or before December 31st.

**NO INTEREST OR PENALTY WILL ACCRUE IF MAKING
PAYMENTS AFTER THE PRE PAY DUE DATES.**
